No. DAT-14/15/2025/111-293.— The Government of Arunachal Pradesh has introduced Unified Pension System (UPS) as an option under National Pension System (NPS) vide notification No. DA/X/01/2025-26 dated 11th August, 2025 with effect from 11th August, 2025. The cut-off date for exercising the option to migrate from National Pension System (NPS) to Unified Pension System was 11th November, 2025.

However, in order to give ample time for decision to be arrived by Government employees as well as for wider participation, the Government of Arunachal Pradesh is **hereby extends the cut-off date for migration from National Pension System (NPS) to Unified Pension System (UPS) till 31st January, 2026 REPEAT 31st January, 2026**

Further, it is to inform that new recruits joining Government service on regular basis on or after 11th August, 2025 should join Unified Pension System (UPS) within 30 (thirty) days from date of joining the service.
