No. DMETR-11012(17)/1/2024/181-193—In exercise of the power conferred under Article 309 of the Constitution of India, the Governor of Arunachal Pradesh is pleased to invoke Rule 16 (Power to relax) of the Arunachal Pradesh Health Service Rules, 2000 for one time relaxation of the provision(s) in column 3 and 4-II(2) part-III of the Schedule-V, waiving off 3 (three) years and 5 (five) years, experience in the concerned Discipline for PG Degree and PG Diploma holders and increasing the upper age limit of 40 years (relaxable) for Government employee by 5 years) to 50 years (for Government Employee) in the event of shortage of candidates for recruitment of Junior Specialist (Allopathy) and Junior Dental Specialist (Allopathy) of various disciplines through APPSC.

No. AGRI/E-29/202.—In exercise of the powers conferred by the proviso to Article 309 of the constitution of India, the Governor of Arunachal Pradesh is pleased to make the following rules further to amend the Statistical Officer (SO) Group - 'B', Gazetted, Non - Ministerial Recruitment Rules, 1997, in the Department of Agriculture, under the Government of Arunachal Pradesh namely:-

1. **Short title and commencement:** (1) These rules may be called the **Agriculture Statistical Officer (ASO) Group - 'B', Gazetted, Non - Ministerial (Amendment) Rules, 2025.**  
(2) They shall come in to force on the date of their publication in the Arunachal Pradesh Gazette.
2. **Amendments to the Principal Rules:** In the Statistical Officer Recruitment Rules, notified vide No. AGRI/E-23/92-94(C) dated 12th September, 1997 (herein after referred to as principal Rules) the word "Statistical Officer" appearing in the short title shall be substituted by the word "Agriculture Statistical Officer".

3. **Amendment to the Schedule:** In column numbers of the Schedules of the Principal Rules, against the existing entries, the following entries shall be substituted: -

- (i) The existing entries in column 1 shall be substituted by the word “**Agriculture Statistical Officer**”.
- (ii) The existing entries in column 4 shall be substituted by the entries “**Level in the Pay Matrix level-6 ₹ 35,400 - 1,12,400 P.M” + allowances.**
- (iii) The existing entries in column 11 shall be substituted by “**100%** by promotion from amongst the Agriculture Statistical Inspector of the Departments 5 (five) years of regular service in the grade and possessing educational qualification of Graduation/Bachelor Degree. Failing which by transfer on deputation from other Departments of the State Government/Central Government holding analogous post of Statistical Inspector and drawing Pay in the Pay Matrix Level 5 ₹ 29,200 - 92,300 PM and possessing educational qualification of Graduation/Bachelor Degree. The maximum age for appointment by deputation/short term contract shall not exceed 56 years as on the closing date of the receipt of the applications. The period of deputation shall ordinarily not exceed 3 years.
- (iv) The existing entries in column 12 shall be substituted by following entries:-

**DPC for promotion/DCC for confirmation of probation period:-**

1. Principal Secretary/Commissioner/Secretary - Chairman
2. Commissioner/Secretary not connected to the work of the Department - Member
3. Head of office - Member
4. One Group -(A) A.P.S.T. Officer if none of the member belong to A.P.S.T. - Member

(v) The existing entries in column 14 shall be substituted by the following entries:-

No. DDM-11024(11)/5/2021/10083-90.—In exercise of the powers conferred by the provision to Article 309 of the Constitution of India, the Governor of Arunachal Pradesh is pleased to make the following Rules to amend the Recruitment rules to the post of **Deputy Director, Group-A Gazetted (Non-Ministerial)** in the Department of Disaster Management under the Government of Arunachal Pradesh, namely:

1. **Short title and commencement:** (i) These rules may be called **Deputy Director Group "A" (Gazetted) (Non-Ministerial) (1st Amendment) Recruitment Rules, 2026.**  
(ii) They shall come into force on the date of their publication in the Arunachal Pradesh Gazette.
2. **Amendment to the Rules :** In the principal Rules Notified vide No. DRR/DM-18/2004 dated 17th June, 2004 for the existing entries in rule 3 the following entries in "Level in Pay Matrix" shall be substituted.
3. **Amendment to the Schedule:** In the Schedule to the Principal Rules, against the entries the following entries shall be substituted:
