(Extension of Declaration under Section (19) of the Right to Fair Compensation in Land Acquisition, Rehabilitation and Resettlement Act, 2013).

No. LMD-13011/17/2024/1276.—**WHEREAS**, the Preliminary Notification under Section 11(1) of the Right to Fair Compensation in Land Acquisition, Rehabilitation and Resettlement Act, 2013 was issued vide No. LMD-13011/17/2024/2132 dated 29th February, 2024 and Declaration under Section 19 was issued vide No. LMD-13011/17/2024/426 dated 8th July, 2024 for acquisition of a land measuring 1393.198 Sqm at Khukri in Shocktsen Village Area under Zemeithang Circle in Tawang District for establishment of ITBP BoP, which has expired on 7th July, 2025. AND WHEREAS, as per sub-section (7) of Section 19 of the Act, where no declaration is made under sub-section (1) of Section 19 within twelve months from the date of issue of Declaration under Section 19, then such notification shall be deemed to have been rescinded. The second proviso to Section 25 of LARR Act, 2013 provides that the appropriate Government shall have the power to extend the period of 12 months, if in its opinion circumstances exist justifying the same ;

AND WHEREAS, the DC Tawang vide letter No. TLR-33/84(Vol-II)/2447-49 dated 27th June, 2025 has requested with reasons to extend the period and the appropriate Government is of the opinion that circumstances existed for inadvertent delay ;

NOW THEREFORE, in exercise of the power conferred by second proviso to sub-section (7) of Section 19 of the Right to Fair Compensation in Land Acquisition, Rehabilitation and Resettlement Act, 2013 (30 of 2013), the Government of Arunachal Pradesh do hereby decide to extend the period of upto 31st August, 2026 for issue of Declaration under Section 19 of the said Act.
